Eligibility & Criteria

Can I Enter the Competition?

Current secondary school students either attending a school in or living in Goldstein are eligible to enter the Goldstein Future Leaders Speech Competition. Eligible submissions must use appropriate content and language and be between 120 and 150 words long.

Why are you running this Competition?

The next generation of Australian leaders will be presented with a series of challenges and opportunities that will shape the long term future of our nation. Addressing the challenge will require a firm understanding of what our community stands for and what we want to achieve.

This competition is being run to encourage young people to consider what values are important in their lives, and to provide a platform for them to advocate for these values into the future. By doing so, we can empower the leaders to be part of the solution to the challenges facing Australia.

How should I choose a topic?

When choosing a topic, it is essential that you consider both the directions of the competition and the theme. This year's theme, ***Taking our community's values to the nation***, asks you to think about what values are important to our community and how they can be used to better guide our nation in the future.

What should I talk about in my speech?

The word limit for the speech is tight, therefore we recommend being direct and pointed. Ensure you answer the following questions:

- What values are important to our community?
- Why are they important to our community?
- How can these values guide the direction of our nation?

How will you judge the competition?

Entries will be judged according to the four criteria outlined below.

Terms and Conditions

1. The purpose of the Goldstein Future Leaders Speech Competition is to;
 - a. Help Goldstein secondary students develop and articulate the values necessary to act as the leaders of tomorrow; and
 - b. Provide students with an opportunity that will empower them to act with integrity and take leadership roles into the future.
2. Participants must meet the following entry criteria:
 - a. Entrants must be a current secondary school student.
 - b. Entrants must either attend a school in Goldstein or live within Goldstein.
3. The 2017 Goldstein Future Leaders Speech entries must be submitted by **5:00 pm on Sunday the 1st of October**.
4. Each entry must be submitted either electronically to Tim.Wilson.MP@aph.gov.au, or physically to 368 Centre Road Bentleigh.
5. Finalists must be available to present their speech in the Office of Tim Wilson MP, located at 368 Centre Rd, Bentleigh between 5pm - 7pm on Thursday 12th of October.
6. By entering the Goldstein Future Leaders Speech Competition, the entrant agrees that the content of the speech may be reproduced in the future.
7. Any person under 18 years old must have a parent or guardian's permission.
8. There is no cost to submit an entry to the Future Leader's Speech Competition. However, any cost associated with the production of the speech, and any cost associated with related events (with the exception of a single return flight to Canberra, and transfers, for one participant) are the responsibility of the entrant.
9. By entering the Goldstein Future Leaders Speech Competition, all entrants warrant the entry is their own original work.
10. Entries must not include the following
 - a. Any material deemed offensive, crude, inappropriate or otherwise improper for the purpose of the Goldstein Future Leaders Speech Competition.
 - b. Any material that infringes the intellectual property of any third party.
11. The competition will be judged by Tim Wilson MP and two other judges.
12. The judge's decision will be final and no correspondence will be entered into.
13. The Office of Tim Wilson MP reserves the right to cancel the competition for any reason at any time.
14. Entrants should keep a copy of entries and entry forms as these will not be returned to the participant following the competition.
15. In the event that an entrant is chosen as a participant in the Canberra experience, the person named as an entrant on the entry form will be the sole recipient of said experience. This opportunity is not negotiable or transferrable.
16. The Canberra Experience is inclusive of:
 - a. Economy Class flights for the winner on the nominated day from Melbourne to Canberra return at the times to be specified by Tim Wilson MP.
 - b. Reimbursement of taxi costs directly from Canberra domestic airport to Parliament House and from Parliament House to Canberra domestic airport. Receipts will need to be kept for reimbursement.
 - c. Lunch will be provided as part of the experience.
17. The following conditions also apply:
 - a. If the winning entrant is aged under 18 years, any costs for an accompanying parent or guardian shall be met at their own expense.
 - b. As escorted passes are required in Parliament House, the winning entrant and guardian, if in attendance, will be under the supervision of Tim Wilson MP or a member of staff.
 - c. While Tim Wilson MP will endeavour to personally conduct all aspects of the Canberra experience, his duties as a member of parliament must take precedence and he may need to step away for parliamentary business in which case a staff member will take over supervision.
18. Finalists and selected winners will be notified via phone, email or mail.
19. The Office of Tim Wilson MP manages information collected from entrants in accordance with the Privacy Act 1988.
20. The Office of Tim Wilson MP reserves the right to contact entrants and associated persons using information obtained in relation to the operations of the competition.
21. Entrants that breach the above Terms and Conditions are subject to disqualification.
